Professional Negligence

He has experience acting for both claimants, defendants and insurers. He has a particular interest in cases which overlap with his construction practice.

Construction

Conor has particular experience in construction disputes and accepts instructions in cases arising from various standard form construction contracts, such as the JCT, ICE, NEC, RIBA and FIDIC contracts. He is particularly sought after in construction disputes which overlap with his professional negligence expertise, including cases involving allegations against architects, engineers, and other contractual parties.

His current and recent cases include a number of multi-million pound cladding claims following the Grenfell Tower fire, as well as claims under the Building Safety Act 2022.
