Lucy Colter practices in commercial litigation including complex civil fraud, construction and professional liability claims.

Lucy has recently worked on some of the biggest and most complex cases in the Commercial Court and is also a highly experienced and robust advocate. She is ranked as a leading junior in the Legal 500 for Commercial Litigation, Offshore, Construction and Professional Negligence and in Chambers & Partners for Commercial Dispute Resolution, Construction, Professional Negligence and Professional Negligence: Technology and Construction. Lucy has been shortlisted for Junior of the Year in the Professional Negligence category at the Legal 500 Awards, and was also nominated for Professional Negligence Junior of the Year at the 2024 Legal 500 Bar Awards

Commercial litigation

Lucy's practice is dominated by complex litigation, including high-value civil fraud. Led by Justin Fenwick KC and George Spalton KC, she represented Nick Suppipat in his US\$billion fraud claims against multiple defendants in the Commercial Court, obtaining a judgment for US\$850 million after a 20 week trial (Suppipat v Narongdej and others [2023] EWHC 1988 (Comm)). In 2022, led by Justin Fenwick KC, Lucy represented Beny Steinmetz in an 11-week Commercial Court trial before Mr Justice Andrew Baker, defending deceit and conspiracy claims for c.US\$1 billion+ brought by the Brazilian mining company, Vale. The claim collapsed midway through trial. Lucy was instructed for Georgy Bedzhamov in Vneshprombank v Bedzhamov and worked for several years on Deripaska v Chernukhin. Lucy also has a growing practice in commercial arbitration, including in the UAE. She also practices as an arbitrator.

Professional Liability



Lucy acts in challenging and high-value claims. She is instructed with Patrick Lawrence KC to defend loss of a chance claims for US\$100m+ against a leading private client firm involving issues of international and cross-border enforcement. She was instructed by a UHNW client bringing lost litigation claims worth US\$500 million+ against a City firm in respect of claims arising out of a failed joint venture and the dissipation of the client's funds worldwide. She acted (led by Graeme McPherson KC) in a claim against a senior tax barrister instructed as an expert in respect of the demerger of a property empire, involving allegations of conflict and bias.

Construction & Engineering

Lucy has extensive trial experience in construction and engineering matters (in the TCC, arbitration and adjudication), acting for multinational construction service companies and development companies, usually as lead or sole advocate. She represented the successful defendant on a preliminary issue in terms of duties owed in *Multiplex Construction Europe Limited v RNP Associates Ltd (in liquidation) and others* [2021] EWHC 590 (TCC), leading Will Cook. She undertakes advisory work in respect of complex contractual issues arising on projects.

Offshore

Lucy's practice involves substantial and diverse offshore work in the Channel Islands; Cayman; BVI and Bermuda. She is instructed in trust matters and litigation; construction matters concerning offshore arbitration and on-shore court claims; and contractual disputes. Her commercial litigation practice very frequently involves an offshore element including in respect of enforcement issues. She has excellent experience of sanctions issues and is presently working on contentious sanctions issues impacting trust arrangements in Bermuda.



Lucy has an extremely busy commercial practice and is ranked as a leading junior in Chambers & Partners and the Legal 500. She is particularly interested in matters with an international element and in which fraud, conspiracy and large-scale dishonesty have been alleged. She has deep experience of fighting highly complex and difficult fraud claims at trial.

Lucy's recent experience includes:

- Acting for Nick Suppipat in *Suppipat and others v Narongdej* and others on US\$2bn+ claims brought by the founder of a Thai wind farm enterprise against a range of defendants including Nop Narongdej and Siam Commercial Bank. The team secured a US\$850 million judgment on behalf of Mr Suppipat and a post-judgment WFO and orders for enforcement in Hong Kong [2023] EWHC 1988 Comm. (Led by Justin Fenwick KC and George Spalton KC).
- Acting for Beny Steinmetz in *Vale SA and others v Steinmetz and others*, in respect of US\$1bn claims in fraudulent misrepresentation, deceit and conspiracy in respect of a joint partnership arrangement, alleging bribery. The trial collapsed part-heard, Vale's claims were dismissed and the WFOs discharged. (Led by Justin Fenwick KC).
- Acting for Cyprus companies in an arbitral dispute with Russian-controlled companies arising out of a joint venture processing waste metal in western Russia.
- Acting in an arbitration concerning investment in a Bulgarian shopping mall and allegations of dishonesty and collusion. (Led by Justin Fenwick KC).

It involved allegations of fraud and corruption and oppressive conduct in the takeover of a business under section 202 of Cyprus Companies Law, along with extensive satellite issues including in the Royal Court in Jersey, impacted by US sanctions against Mr Deripaska. (Led by Justin Fenwick KC). Reported as (1) Filatona Trading Limited (2) Oleg Vladimirovich Deripaska v (1) Navigator Equities Limited (2) Vladimir Anatolevich Chernukhin [2019] EWHC 173 Comm and [2020] EWCA Civ 109.
- Acting for an insurer in a dispute with a state-owned oil company in ICC arbitration in Abu Dhabi. (Led by David Turner KC).
- Acting for a Jersey trust company in respect of proceedings in the Royal Court to recover losses allegedly suffered by a discretionary trust. Lucy's practice includes substantial and diverse work in this area. Her commercial litigation practice (particularly Russian/CIS litigation) involves a strong offshore element. Lucy also has extensive experience dealing with contentious sanctions issues in various jurisdictions including Bermuda.



Lucy's recent experience includes:

- Acting in contentious matters relating to sanctions and their impact on trust structures in particular in Bermuda.
- Advising on claims concerning the enforcement of English judgments in multiple offshore jurisdictions including Cayman.
- Representing a Jersey trust company in an action in the Royal Court in respect of losses allegedly suffered by a
 discretionary trust. The claim concerned allegations of a failure to implement an adequate investment strategy and
 allegations of gross negligence and fraud regarding alleged LIBOR and fx manipulation.

Civil Fraud

Lucy has been instructed in some of the largest civil fraud claims in the Commercial Court in recent years, including at trial, and she also has experience of LCIA and ICC arbitration in particular. Lucy's cases are frequently extremely high in value and highly contested proceedings involving serious and very complex allegations and issues.

Over the last 4 years, she has worked on Suppipat v Narongdej and others (a 17 week trial); Vale v Steinmetz and others (an 11 week trial in which Vale discontinued); and Vneshprombank LLC v Bedzhamov and others. She was involved for several years in the long-running dispute between Oleg Deripaska and Vladimir Chernukhin, representing Mr Deripaska in the LCIA; trial in the Commercial Court; and the Court of Appeal. She acts for both claimants and defendants. She has extensive experience acting for UHNW clients and associated entities. She also has extensive experience of proceedings concerning complex company and trust structures including offshore.

Featured Cases

- Suppipat & Ors v Narongdej & Ors Lucy acted for Nick Suppipat, the Claimant in this US\$2 billion+ unlawful means conspiracy, fraud and bribery claim with significant multi-jurisdictional aspects, securing judgment for US\$850 million in 2023. This case was featured in The Lawyer's Top 20 cases of 2022. The 400-page judgment is reported as [2023] EWHC 1988 (Comm). Led by Justin Fenwick KC and George Spalton KC.
- Vale v Steinmetz and others Lucy acted for Beny Steinmetz in this \$1 billion+ fraudulent misrepresentation, deceit and conspiracy claim arising out of a disputed joint venture in respect of a mine in Guinea. Vale abandoned their claims in the 4th week of an 11 week trial. Led by Justin Fenwick KC.
- Vneshprombank LLC v Georgy Bedzhamov & Ors Lucy acted for Georgy Bedzhamov in highly contested proceedings brought by a Russian bank in liquidation for a massive alleged fraud, seeking damages of over £2 billion, including in respect of issues arising out of a WFO and search order.
